in this breaker panel is noted several spliced wires...appears the panel is at capacity and may need upsized...



two of four spliced wiring noted..this is where two circuits are powered by one breaker and wired away from breaker



the idea can be fine at low use circuits..but can pop breakers alot if overused.....expect breakers to "pop"



laundry area is noted visible...floor moisture is noted low..



washer connections are noted drip free...



dryer connections are noted fine...



laundry room walls appear fine..can see around stored items pretty well...fixture is noted operable...



appears extra flooring is noted at laundry room and may be from side bedroom area...




back bedroom 3 is noted with window operable...



exterior walls are detected low in moisture...good..



entry and closet doors are noted operable...door hinge at base is bad....



while Cadet wall heater is noted operable...it is to close to entry door and can be fire hazard...



side bedroom behind kitchen is noted with window operable..



low moisture is noted at all areas of exterior wall



Cadet wall heater in this room is noted not operable...replace...



tried again with use of plyers to try to get switch to respond...replace...



entry and closet doors and fixture are noted operable...



master bedroom window is noted operable...



low moisture is noted at lower wall area...good..



entry and closet doors are noted operable...lupper hinge at door is noted damaged...



Cadet wall heater is noted operable..



areas at ceiling and wall where stained and dark are noted low in moisture at this time...



low moisture is noted at ceiling area at corner as well...



master bath entry door and cabinets are noted
 operable...ceiling fan / cover is noted
 missing...replace...



sink faucet is noted operable..no drain stop noted...



hot water is noted fine...



no drips or leaks noted under sink area at master 11920



floor at tub area center at mastyer is noted low...caulk is needed at rim areas of flooring..



shower head is noted operable...shower doors need towel bar and door handle...



faucet is noted operable...but drain stop not operable...



hot water is noted slow flow at master tub area...



floor...back corner of floor at right side...



one area of master bath is noted with high moisture at toilet is noted solid to floor and operable...floor is noted low in moisture at rest of areas...




11920 main bath entry door and cabinets are noted operable..

faucet needs repairs and sink has surface damage...drain is operable...but drain stop is noted not operable..



plug in main bath is at floor and not GFCI...correct...



fixtures noted not operable...



toilet is noted operable...and floor moisture is noted $\ensuremath{\text{low}}\dots$



floor moisture at tub area is noted low as well...



tub faucet is noted operable..drain stop not operable...monitor grout at tile walls...



shower head is noted operable..



hot water is noted fine in main bath area 11920



ceiling fan is noted operable...and low moisture at ceiling area...



hall closet door and shelves noted operable..



ceiling fixture and door bell noted operable...



living room Cadet wall heater is noted operable..



Cadet wall heater in dining area is noted operable..



front entry door and window are noted operable..



threshold is noted solid to floor and floor moisture is noted low..at front door area...



dining room fixture and slider to patio are noted operable..



upper center wall cabinets and counter to side are noted solid and operable..side cabinet to left is noted loose...



not sure why...loose and cut open at formica...



all burners are noted operable...oven is not tested...stored items in oven



refrigerator is noted operable..



freezer is noted cold enough to keep ice cream hard...



refrigerator is noted operable...



main cabinets and counter are noted operable..counter
has surface damage...window is noted operable..



dishwasher is noted not operable....will need replaced...



floor moisture is noted low at dishwasher ${\tt area...good..}$




garbage disposal isoperable..hose bib shut off needs handle..armoured cable good..high loop needed for drain...

second area is also noted fine..low moisture and wood staining..




NO...the sprayer arm is not allowed to be set up as noted...will leak and cause damage..remove...
